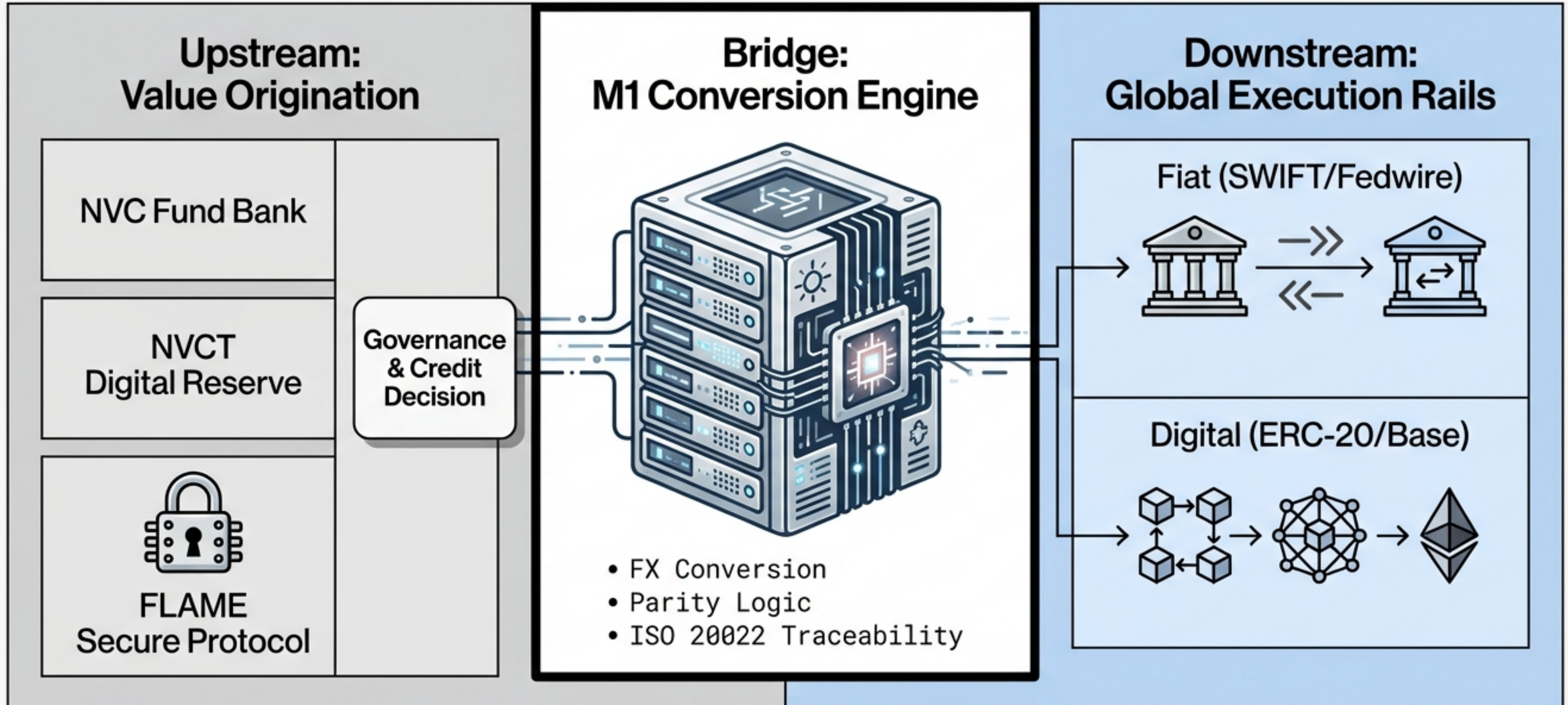

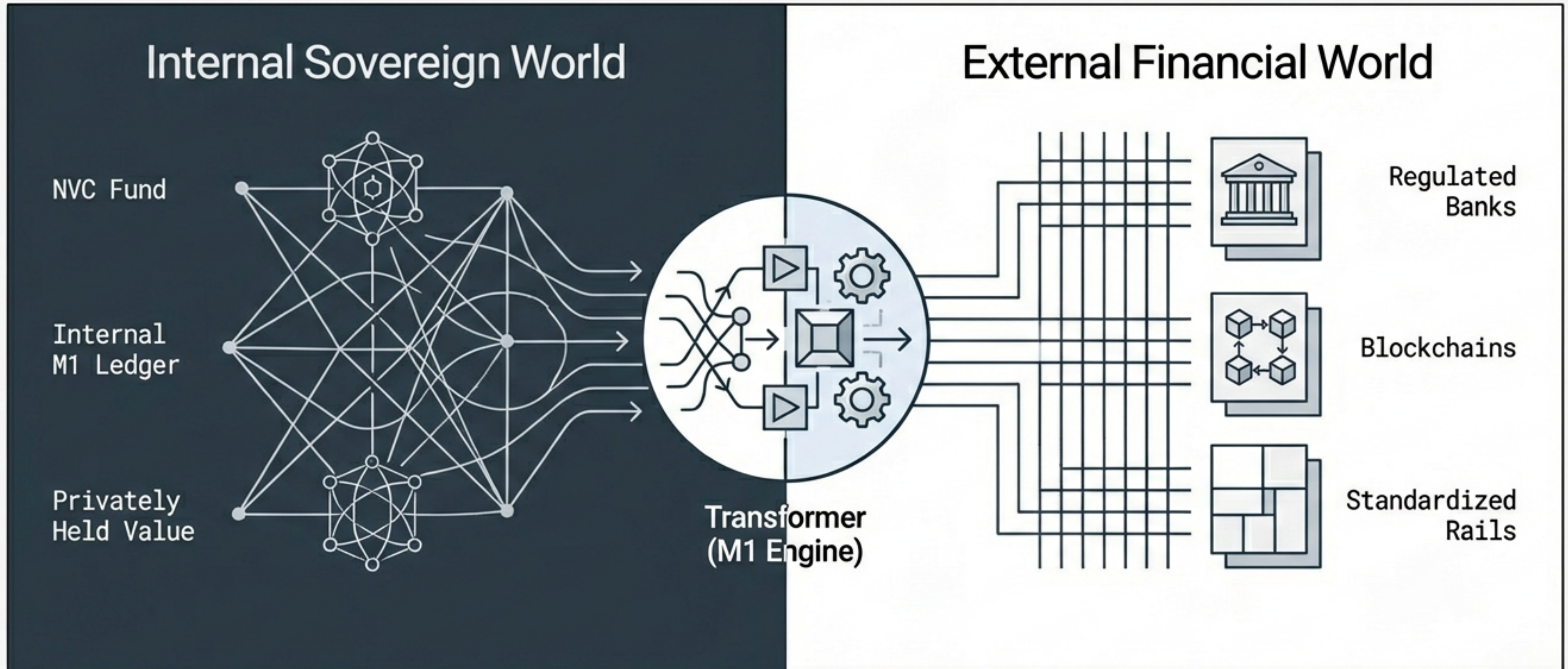
Confidential Architecture Overview

The M1 Architecture in the NVC Settlement Stack



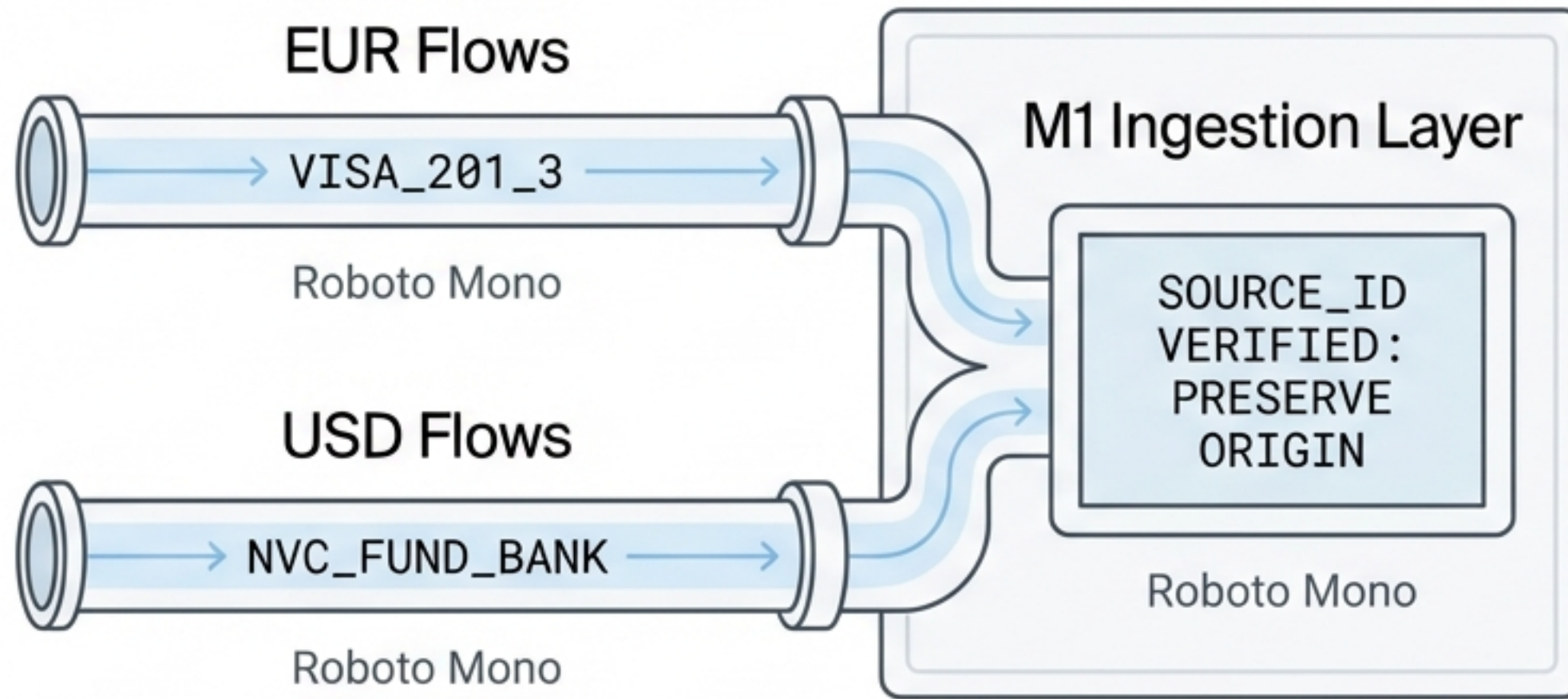
The M1 System acts as the 'Monetary Expression Layer,' functioning as the sole bridge between sovereign internal accounting and external financial networks.

Bridging Sovereign Accounting and Global Finance



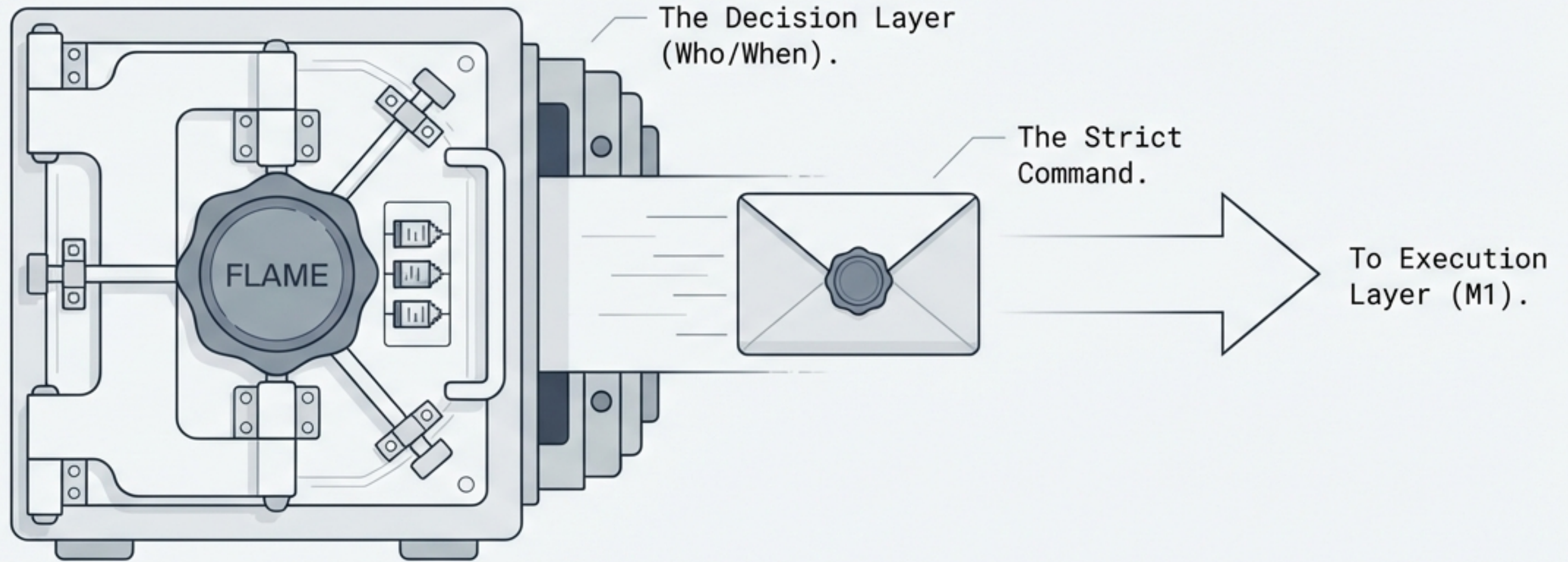
The Challenge: Moving value from a sovereign ledger to a commercial bank account requires a translation layer that preserves the 'strict command' of the internal system while ensuring the output is regulator-legible.

Upstream Origination: Fund-Source Awareness



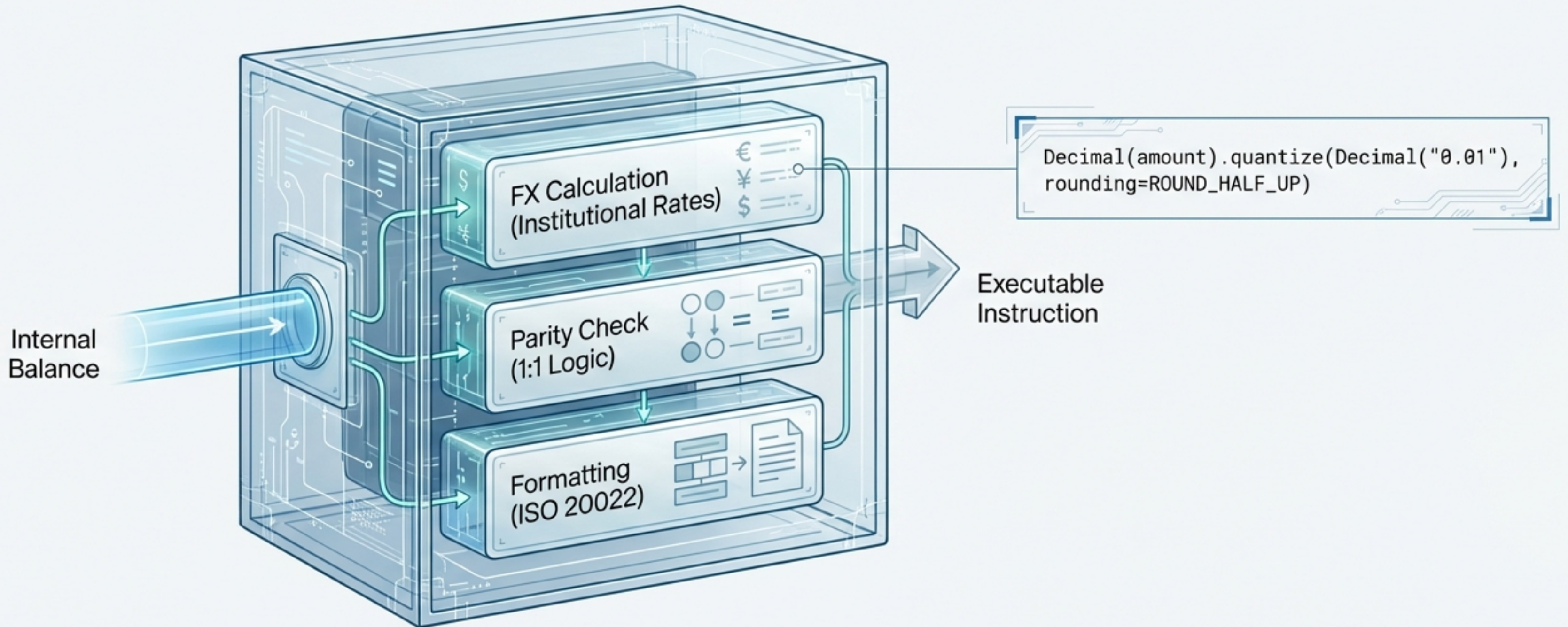
The M1 system is natively “fund-source aware.” It recognizes internal ledger inputs immediately, ensuring that funds originating from specific sovereign structures (like Protocol 201.3) are routed and logged correctly from the moment of ingestion.

FLAME: The Cryptographic Decision Layer



FLAME does not move money. It cryptographically enforces *when* value moves and *who* receives it. It issues a strict command: "Release X from Fund Y to Beneficiary Z." M1 translates this into action.

The M1 Conversion Engine: Core Mechanics



Transforming internal balances into regulator-legible instructions using institutional precision.

Parity Logic and Value Materialization

1 NVCT = 1 USD = 1 STABLECOIN



The system maintains a rigid peg across the NVC Digital Reserve and the US Dollar. This mechanism allows the system to 'materialize' internal digital value into real-world, spendable money instantly. It is not a trade; it is a materialization.

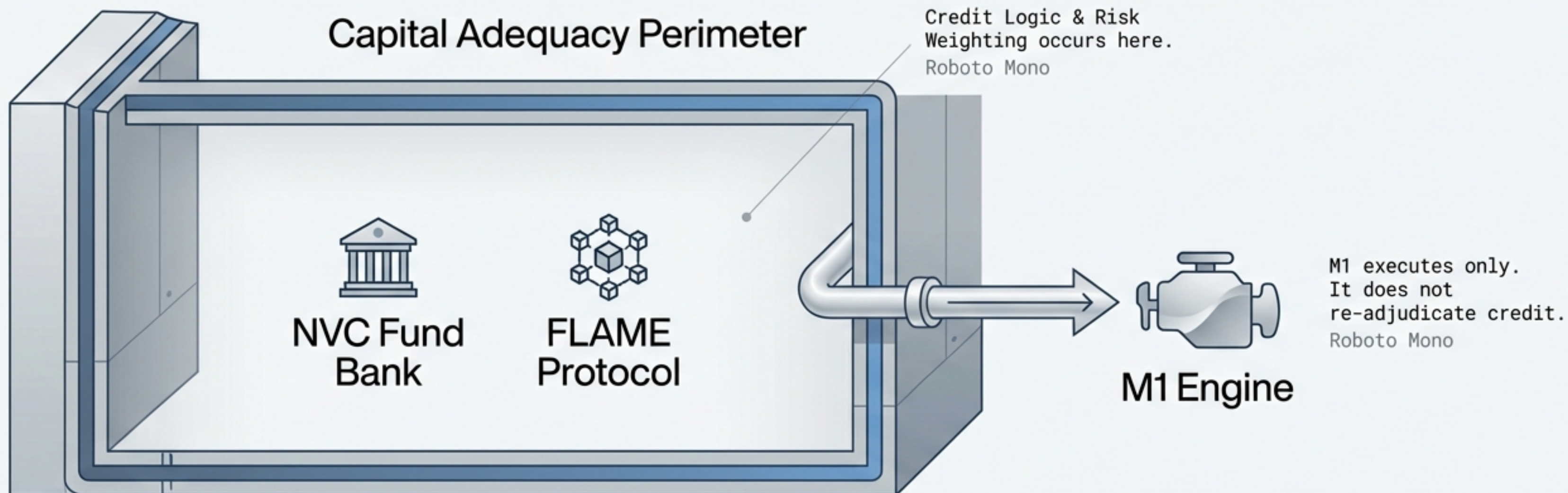

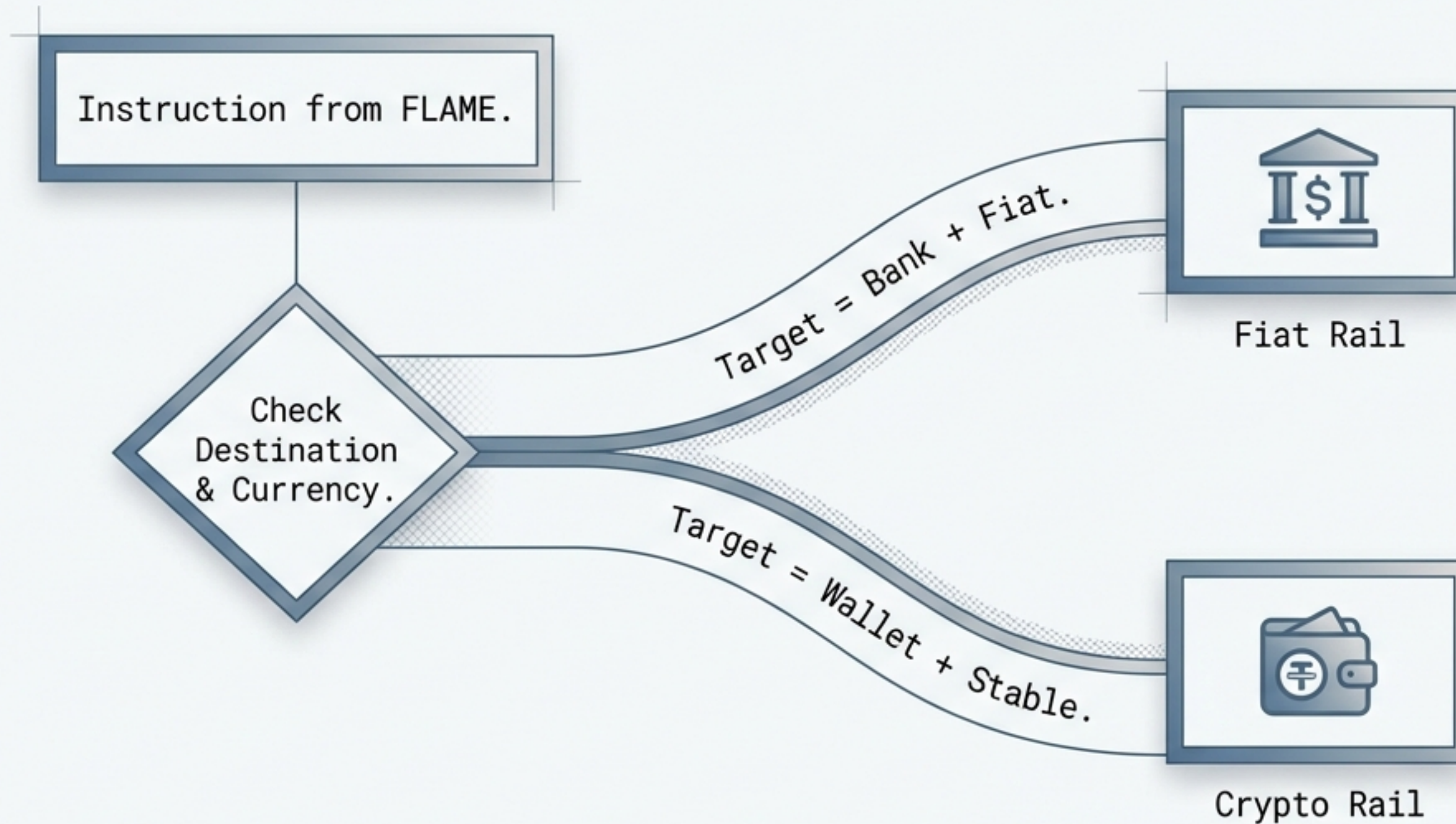
Deterministic Transaction IDs create a **'Single Source of Truth'** database that is fully legible to external auditors and regulators.

M1 is an execution engine, not a credit engine. This separation preserves the Basel III capital adequacy logic established upstream by the NVC Fund Bank.

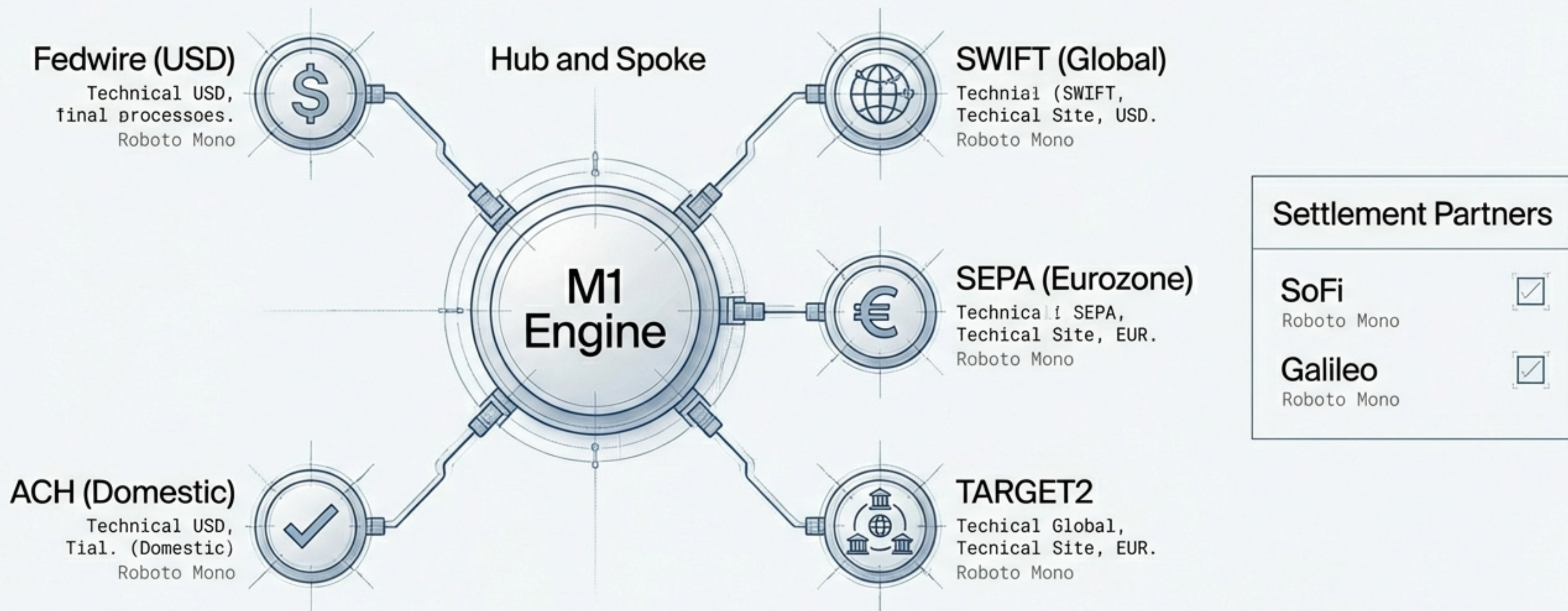
Intelligent Multi-Rail Routing

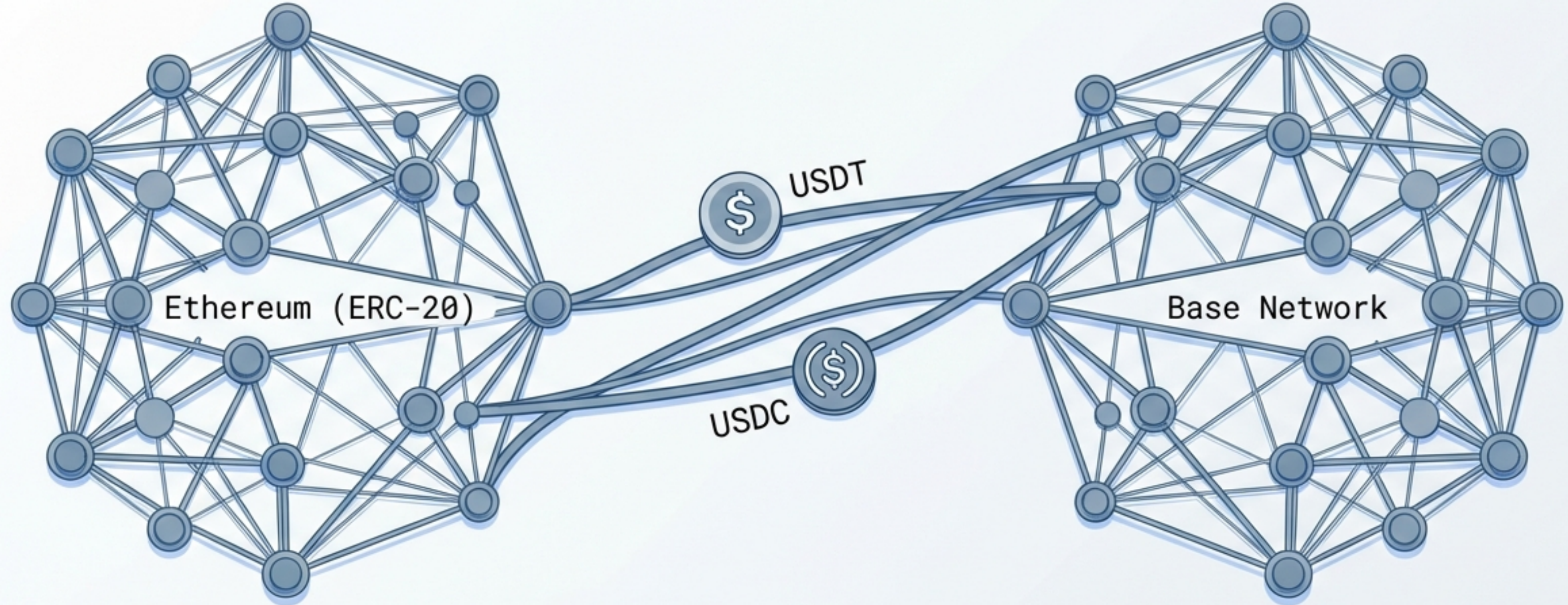
The routing is deterministic based on the strict command from FLAME.

Digital Execution: Blockchain Interoperability

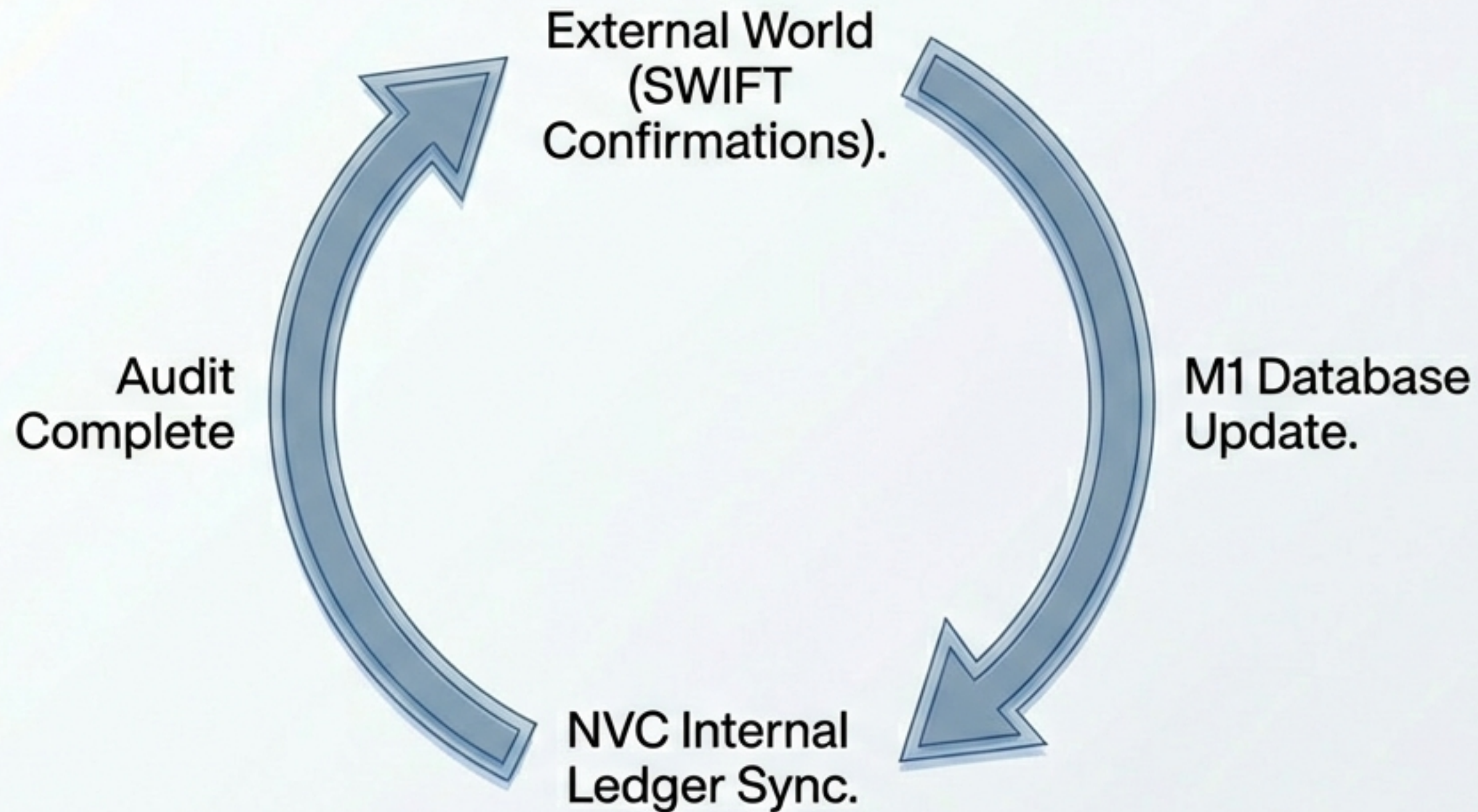


Seamless 1:1 conversion to USDT/USDC for instant digital settlement.

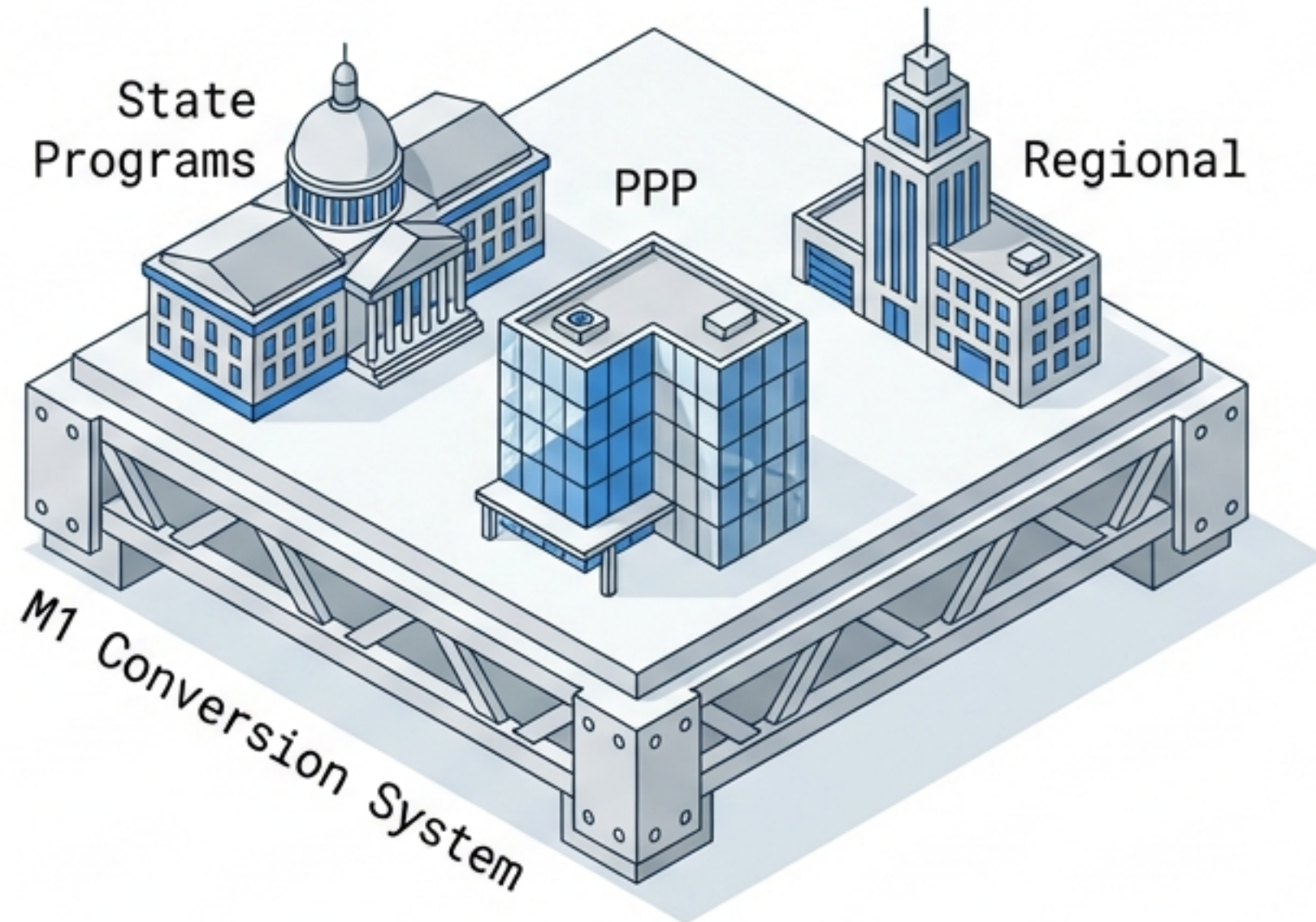


Reconciliation and The Feedback Loop
